CERTIFICATE OF WATER RIGHT

This Is to Certify, That **LESTER S. or VIOLA M. WELLS**

of Wolf Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coon Hollow Creek and Wolf Creek

a tributary of Grave Creek for the purpose of irrigation of yard not exceeding 0.1 acre in area and domestic use of one family

under Permit No. 27854 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 20, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second; being 0.01 c.f.s. for irrigation from Coon Hollow Creek, water to be diverted from Coon Hollow Creek when available and any deficiency in the available water from Coon Hollow Creek to be made up by diversion * or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 21, T. 33 S., R. 6 W., W. M.

Diversion points located: Coon Hollow - 980 feet East and 20 feet North; Wolf Creek - 430 feet North and 1070 feet East; both from W $\frac{1}{2}$ Corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the Rogue River is more than 735 c.f.s. at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic and 0.1 acre SW $\frac{1}{4}$ NW $\frac{1}{4}$
Section 21
T. 33 S., R. 6 W., W. M.

* from Wolf Creek providing the total quantity of water from both sources shall not exceed 0.01 c.f.s. and 0.01 c.f.s. for domestic from Coon Hollow Creek,

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
