of P. O. Box 16, Springfield , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Middle Fork Willamette River through Georgia Pacific Mill Race

a tributary of Willamette River irrigation of 34.7 acres and manufacturing (washing gravel) for the purpose of

under Permit No. 29217 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 16, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.73 cubic feet per second, being 0.43 c.f.s. for irrigation and 1.30 c.f.s. for manufacturing

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the River - NW NW, as projected within Maguess DLC 50, Section 8, T. 18 S., R. 2 W., W. M. Race Rediversion - NE NW, as projected within Briggs DLC 39, Section 1. T. 18 S., R. 3 W., W. M. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of Middle Fork Willamette River is more than 1025 c.f.s. at its mouth. This right is subject to maintenance and use of adequate treatment facilities to remove the sediment before returning the water to the stream.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Diversion points described more explicitly as follows: River - 1150 feet South and 400 feet West from SW Corner of Arthur DLC 63; Race - North 38° 03' 55" East 3032,46 feet from Wr Corner, Section 1.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
