CERTIFICATE OF WATER RIGHT

This Is to Certify, That KEITH AND NINA LEONARD

of Box 193, Umpqua, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Porter Creek

a tributary of Umpqua River for the purpose of irrigation of 8.7 acres

under Permit No. 28820 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 32, T. 24 S., R. 7 W., W. M. Diversion point located 400 feet South and 710 feet East from the NW Corner, SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the Umpqua River is more than 525 c.f.s. at tidewater;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre Lot 1 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
4.8 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
3.4 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 32
T. 24 S., R. 7 W., W. M.

This certificate is issued to correct and supersede the Certificate of Water Right issued to Keith and Nina Leonard and recorded at page 34023, Volume 26, State Record of Water Right Certificates, so as to correctly describe the lands irrigated.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
