**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**        EMERY J. JONES and IRENE L. JONES

of 7745 North River Road, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Lake Labish Main Ditch (Pudding River) for the purpose of irrigation of 12.0 acres

under Permit No. G-2645 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 30, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Lacerti DLC 71, Section 29, T. 6 S., R. 2 W., W. M. Well located 4100 feet North and 930 feet West from the SE Corner, Section 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.9 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
10.1 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$   
both as projected within Lacerti DLC 71  
Section 29  
T. 6 S., R. 2 W., W. M.

Certificate of water right issued to Emery J. Jones and Irene L. Jones and recorded at page 34267, Volume 26, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 17.5 acres. Subsequently, the right to the use of water appurtenant to 5.5 acres was canceled by order of the State Engineer entered December 17, 1968. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Emery J. Jones and Irene L. Jones.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
