## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

J. F. HUTCHINSON

, State of Oregon , has a right Union to the use of the waters of Catherine Creek a tributary of Grande Ronde for the purpose of irrigation of 124.5 acres and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8 , at page 1 ; that the priority of the right thereby confirmed dates from 1864 for Tract No. 1; 1867 for Tract No. 2; 1876 for Tract

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre;

Certificate of water right issued to J. F. Hutchinson and recorded at page 6388, Volume 6, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 206.0 acres. A change in the right to the use of water appurtenant to 81.5 acres was approved by orders of the State Engineer entered February 23, 1950, and May 27, 1968. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to J. F. Hutchinson.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
