CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GALE MERWIN and KATHRYN M. MERWIN

of Post , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Watson Creek, two unnamed streams and Rabbit Valley Reservoir constructed under Appl. No. R-34656, Permit No. R-2649 a tributary of Crooked River for the purpose of irrigation of 98.0 acres

under Permit No. 27516 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **February 27, 1961**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.45 cubic feet per second; being 1.30 c.f.s. from Watson Creek and reservoir, 0.86 c.f.s. from east unnamed stream, 0.29 c.f.s. from west unnamed stream

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL SEL, NWL SEL, Section 15; SEL SEL; Section 22; T. 16 S., R. 22 E., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortleth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under permit No. R-2649;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre SW NET SET 38.0 acres NET SET 7.0 acres SW SET 12.7 acres SET SET Section 22
T. 16 S., R. 22 E., W. M.

Diversion points located: East Stream - 1550 feet North and 2290 feet East; West Stream - 1580 feet North and 700 feet East; Watson Creek - 4420 feet South and 2490 feet East; all from N_h^2 Corner, Section 22.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
