**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      **ALLEN L. GUERBER**

of Route 1, Box 426, Corvallis, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Well No. 4

a tributary of Willamette River for the purpose of irrigation of 35.4 acres

under Permit No. G-2393 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 2, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 19, T. 11 S., R. 4 W., W. M. Well located 214 feet North and 880 feet East from NE Corner, Stewart DLC 49.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre SW $\frac{1}{4}$  SW $\frac{1}{4}$   
8.5 acres Lot 3 (SE $\frac{1}{4}$  SW $\frac{1}{4}$ )  
Section 18

4.3 acres Lot 2 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
12.6 acres Lot 3 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
9.2 acres Lot 4 (NW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
Section 19

Certificate of water right issued to Allen L. Guerber and recorded at page 31691, Volume 23, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 65.0 acres. Subsequently, the right to the use of water appurtenant to 29.6 acres was canceled by order of the State Engineer entered May 13, 1966. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Allen L. Guerber.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
