CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROGER COPENHAVER

of Route 4, Box 167-C, Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork of Willamette River

a tributary of Willamette River for the purpose of irrigation of 5.55 acres

under Permit No. 22207 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 20, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 9 (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 20, T. 18 S., R. 2 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre Lot 6 (NW $\frac{1}{4}$ SW $\frac{1}{4}$)
0.7 acre NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Whitmore DLC 82
2.0 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Whitmore DLC 82
2.05 acres Lot 9 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)

T. 18 S., R. 2 W., W. M.

Land on which water is to be used is part of that described as follows: Beginning at a certain iron pipe, said pipe being 1891.75 ft. S. of a point which is 1155 ft. E. of the NW Corner of the Thomas Whitmore DLC 82, T. 18 S., R. 2 W., W. M., from said beginning point run thence E. 1001.88 ft. to the middle of the Coast Fork of the Willamette River, thence N. 29° 16' E. along the midline of said River 356.9 ft., thence leaving said mid-line & run W. 1174.4 ft. thence S. 311.4 ft. to the place of beginning being a part of said Thomas Whitmore DLC in Sec. 20, said T. & R., in Lane County, Oregon.

This certificate is issued to correct and supersede the certificate of water right issued to Roger Copenhaver and recorded at page 23913, Volume 17, State Record of Water Right Certificates, so as to correctly describe the lands irrigated. The right to the use of the water for the purposes aforesaid is restricted to the lands of place of use herein described.
