**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      **VANCE RUSSELL**

of Route 1, Box 2931, Coquille, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of 3 sumps

a tributary of Coquille River for the purpose of frost control, harvesting of cranberries, and supplemental irrigation of 19.7 acres under Permit No. G-2561 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 24, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.11 cubic feet per second, being 0.49 c.f.s. for irrigation and frost control and 1.11 c.f.s. for harvesting of cranberries, provided that this quantity together with the amount appropriated under Certificate No. 35933 shall not exceed \* or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NW $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 3; NE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 4; T. 28 S., R. 14 W., W. M. Sumps located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year for the irrigation of cranberries; if for the irrigation of any other crop, this appropriation shall be limited to one-eighth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year; and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.6 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
Section 4  
T. 28 S., R. 14 W., W. M.

\*1.11 cubic foot per second,

Sumps located: No. 1 - 100 feet South and 260 feet East; No. 2 - 550 feet South and 100 feet East; No. 3 - 500 feet South and 150 feet West; all from NW Corner, Section 3.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
