CERTIFICATE OF WATER RIGHT

This Is to Certify, That **VANCE RUSSELL**

of Route 1, Box 2931, Coquille, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed drain ditches and three reservoirs constructed under Appl. No. R-39324, Permit No. R-3900 a tributary of Coquille River for the purpose of frost control, harvesting of cranberries, and irrigation of 19.7 acres

under Permit No. 29282 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 24, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.11 cubic feet per second; being 0.44 c.f.s. from drain ditch No. 1 and reservoirs No. 1 and No. 2 and 0.05 c.f.s. from drain ditch No. 2 and reservoir No. 3 for irrigation of cranberries and frost control; 1.0 c.f.s. from drain ditch * or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 3; NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 4; T. 28 S., R. 14 W., W. M. Diversion points located: 100 feet South and 260 feet East; 550 feet South and 100 feet East; 500 feet South and 150 feet West; ** The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under permit No. R-3900 for irrigation of cranberries; if for irrigation of any other crop, this appropriation shall be limited to one-eighth of one cubic foot per second or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion *** and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.1 acres Lot 4 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)
Section 3
13.6 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 4
T. 28 S., R. 14 W., W. M.

*No. 1 and reservoirs No. 1 and No. 2 and 0.11 c.f.s. from drain ditch No. 2 and reservoir No. 3 for harvesting of cranberries, provided that this quantity together with the amount appropriated under Certificate No. 35931 shall not exceed 1.11 cubic foot per second,

**All from NW Corner, Section 3.

***of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under permit No. R-3900.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
