## CERTIFICATE OF WATER RIGHT

of Lake Creek , State of . Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rocky Gulch and supplemental storage under Appl. No. R-31307, Permit No. R-1982\* a tributary of Lake Creek

supplemental irrigation of 266.0 acres under Permit No. 24687 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 17, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.30 cubic feet per second from Gulch and 300 acre feet of supplemental storage from Woodrat Knob Rejervoir
