of Route 2, Box 185, Springfield , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Boulder Creek, Pebble Creek and McKenzie River

a tributary of Willamette River irrigation of 30.0 acres

for the purpose of

under Permit No. 27491 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 14, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes, aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.37 cubic foot per second; being 0.13 c.f.s. from Boulder Creek, 0.01 c.f.s. from Pebble Creek and 0.23 c.f.s. from McKenzie River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4, SW4, NW4, SW4, Section 26; NW4 NW4, Section 35; T. 17 S., R. 1 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
