**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**        **CHARLES PAESSLER**

of **Route 2, Box 161, Silverton**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Pudding River**

a tributary of **Molalla River** for the purpose of irrigation of **36.4 acres**

under Permit No. **29791** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **June 22, 1964**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.45 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 17, NE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 20**, both as projected within Tucker DLC 59, T. 6 S., R. 1 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$  acre feet per acre** for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.4 acres NE $\frac{1}{4}$  SE $\frac{1}{4}$   
0.8 acre NW $\frac{1}{4}$  SE $\frac{1}{4}$   
1.6 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Tucker DLC 59  
14.7 acres SE $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Tucker DLC 59  
Section 17  
  
8.9 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Tucker DLC 59  
Section 20  
T. 6 S., R. 1 W., W. M.

Diversion points located: 790 feet South and 1490 feet West; 2000 feet South and 1280 feet West; Both from NE Corner, SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 17.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
