CERTIFICATE OF WATER RIGHT

This Is To Certify, That LLOYD NICHOLSON

of Fort Klamath , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two unnamed drainways

a tributary of Agency Lake for the purpose of

supplemental irrigation of 563.4 acres from unnamed drainway No. 1 and 66.1 * under Permit No. 29505 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 3, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 10.32 cubic feet per second; being 9.0 c.f.s. from Drain No. 1 and 1.32 c.f.s. from Drain No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL SEL, Section 13, T. 33 S., R. 6 E., W. M. SEL NEL, NEL, SEL, SEL, Section 19, T. 33 S., R. 7½ E., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
