CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PRESTON FULLBRIGHT, MARTIN E. and LILLIAN E. KELLOGG, MILES H. and CAROLINE S. WILLIAMS, EARLIE WILLIAMS MARSHALL, MARGARET ELLENE CARLSON and LEO W. BICKEL of Shady Cove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean irrigation of 15.6 acres

for the purpose of

under Permit No. 8572 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 5, 1928

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SE 1/4, SE 1/4 SE 1/4, Section 21, T. 34 S., R. 1 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Diversion points located: 1765 feet North and 1105 feet West; 1550 feet North and 1070 feet West; 1335 feet North and 1045 feet West; and North 50° West 1500 feet; All from the SE Corner, Section 21.

Certificate of water right recorded at page 10543, Volume 10, State Record of Water Right Certificates, confirms a right to the use of water for the irrigation of 28.0 acres. Subsequently the right to the use of water for the irrigation of 2.4 acres was canceled by an order of the State Engineer entered May 11, 1964. This certificate is issued to confirm the remaining right to the use of water for irrigation and confirm changes in points of diversion approved by orders of the State Engineer entered October 1, 1941, and April 6, 1964, and supersedes certificate of water right recorded at page 10543, Volume 10, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
