CERTIFICATE OF WATER RIGHT

This Is To Certify, That

CASCADE RANCHES, INC.

of Lake Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rocky Gulch and supplemental storage under Appl. No. R-31307, Permit No. R-1982* a tributary of Lake Creek for the purpose of supplemental irrigation of 266.0 acres under Permit No. 24687 of the State Engineer, and that said right to the use of said waters

has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 17, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.30 cubic feet per second from Gulch and 300 acre feet of supplemental storage from Woodrat Knob Regervoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL NWL, Section 6, T. 37 S., R. 2 E., W. M. NEL NEL, Section 36, T. 36 S., R. 1 E., W. M. Diversion points located: 980 feet West and 850 feet South from NL Corner, Section 6, T. 37 S., R. 2 E., W. M., 270 feet West and 670 feet South from NE Corner. Section 36. T. 36 S., R. 1 E. W. M.

feet West and 670 feet South from NE Corner, Section 36, T. 36 S., R. 1 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage under Permit No. R-1982 in Woodrat Knob Reservoir constructed under Permit No. R-1839,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
