**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      A. J. ANDERSON

of Star Route, Box 90, Winston, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Olalla Creek

a tributary of South Umpqua River for the purpose of irrigation of 28.1 acres

under Permit No. 29913 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 31, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  SE $\frac{1}{4}$ , SE $\frac{1}{4}$  SE $\frac{1}{4}$ , as projected within McCullough DLC 46, Section 20, T. 29 S., R. 7 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.0 acres NE $\frac{1}{4}$  SE $\frac{1}{4}$

1.7 acres NW $\frac{1}{4}$  SE $\frac{1}{4}$

9.0 acres SE $\frac{1}{4}$  SE $\frac{1}{4}$

all as projected within McCullough DLC 46  
Section 20

0.3 acre SW $\frac{1}{4}$  SW $\frac{1}{4}$

as projected within McCullough DLC 46  
Section 21

2.1 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$

as projected within McCullough DLC 46  
Section 29

T. 29 S., R. 7 W., W. M.

Diversion points located: 720 feet South and 950 feet East; 1750 feet South and 910 feet East; both from most westerly NW corner, McCullough DLC 46.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
