CERTIFICATE OF WATER RIGHT

This Is to Certify, That **WALTER R. and LUCILLE A. DAVIDSON**

of **Box 232, South Myrtle Route, Myrtle Creek**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **South Myrtle Creek**

a tributary of **South Umpqua River** for the purpose of
irrigation of 12.1 acres

under Permit No. **30152** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 3, 1964**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.15 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected within **Stephens DLC 38**, Section 22, T. 29 S., R. 4 W., W. M. Diversion point located 20 feet North and 2430 feet East from SW Corner, DLC 38. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.4 acre	SW $\frac{1}{4}$ NW $\frac{1}{4}$	as projected within Stephens DLC 38
1.4 acres	Lot 8 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)	
2.2 acres	SE $\frac{1}{4}$ NW $\frac{1}{4}$	as projected within Stephens DLC 38
5.0 acres	Lot 7 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)	
2.0 acres	Lot 7 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)	
1.1 acres	Lot 8 (NW $\frac{1}{4}$ SW $\frac{1}{4}$)
