CERTIFICATE OF WATER RIGHT

This is to Certify, That S. B. CHANDLER

of Lakeview, State of Oregon has a right to the use of

the waters of Creeked Creek, Clover Creek, and small unnamed stream, tributary to Crooked Creek, a tributary of Chewaucan River for the purpose of the irrigation of 317½ acres of land, and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Lake County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 5, at page 1; that the priority of the right thereby confirmed dates from 1880

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of diversion of 1/25 of a cubic foot per second per acre, and the aggregate quantity set forth below; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows: (3.9 acre feet per acre during each irrigation season, being the period from April 1 to September 15 of each year)

38 acres in the Southwest quarter of Northwest quarter; 37 acres in the Northwest quarter of Southwest quarter and 2 acres in the Southwest quarter of Southwest quarter of Section Sixteen; 2½ acres in the Northeast quarter of Northeast quarter; 13 acres in the Southeast quarter of Northeast quarter; 13½ acres in the Northeast quarter of Southwest quarter; 17 acres in the Southeast quarter of Southwest quarter; 27 acres in the Northeast quarter of Southeast quarter; 4½ acres in the Northwest quarter of Southeast quarter; 2½ acres in the Southwest quarter of Southeast quarter and 10½ acres in the Southeast quarter of Southeast quarter of Section Seventeen; 1½ acres in the Northeast quarter of Northeast quarter; 10½ acres in the Southeast quarter of Northeast quarter and ½ acre in the Northeast quarter of Southeast quarter of Section Nineteen; 13 acres in the Northwest quarter of Northeast quarter; 39 acres in the Southwest quarter of Northeast quarter; 12½ acres in the Southeast quarter of Northeast quarter; 15 acres in the Northeast quarter of Northwest quarter; 16 acres in the Northwest quarter of Northwest quarter; 11½ acres in the Southwest quarter of Northwest quarter; 14 acres in the Southeast quarter of Northwest quarter; 3 acres in the Northeast quarter of Southeast quarter and 14½ acres in the Northwest quarter of Southeast quarter of Section Twenty, Township Thirty-six South, Range Twenty-one East of Willamette Meridian, in Lake County, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
