CERTIFICATE OF WATER RIGHT

This Is to Certify, That CENTURY RANCH (LOSSIE HOWARD)

of Route 2, Box 1090, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Well No. 1 and Well No. 3

a tributary of Silver Creek (Silver Lake) for the purpose of irrigation of 107.3 acres, being 28.6 acres from Well No. 1 and 78.7 acres from Well No. 3

under Permit No. G-2165 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 11, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.34 cubic feet per second, being 0.36 c.f.s. from Well No. 1 and 0.98 c.f.s. from Well No. 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4, SE 1/4, NW 1/4, SE 1/4, Section 27, T. 27 S., R. 17 E., W. M. Wells located: No. 1 - 2650 feet South and 2590 feet West; No. 3 - 3570 feet South and 1290 feet West; both from NE Corner, Section 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
