## CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. W. FITTS

of 5334 Quail St. NE, Rt. 6, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Well No. 7

a tributary of Lake Labish (Pudding River) irrigation of 175.0 acres

for the purpose of

under Permit No. G = 3646of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 7, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.19 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SWL, as projected within Lacerti DIC 71, Section 20, T. 6 S., R. 2 W., W. M. Well located 3170 feet South and 1040 feet
East from the westerly SW Corner, Morson DLC 68.
The amount of water used for irrigation, together with the amount secured under any other

right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer.
