CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN L. LESHER, BY: IDA A. LESHER

of 8006 Portland Rd., N. E., Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Lake Labish Drain Ditch for the purpose of irrigation of 33.55 acres

under Permit No. G-2785 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 17, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 NE 1/4, as projected within Lacerty DLC 71, Section 29, T. 6 S., R. 2 W., W. M. Well located 2040 feet East and 330 feet South from NE Corner, Stephens DLC 37. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.3 acre NE 1/4 NE 1/4 as projected within Lacerty DLC 71
 - 12.2 acres SW 1/4 NE 1/4 as projected within Lacerty DLC 71
 - 7.4 acres SE 1/4 NE 1/4 as projected within Lacerty DLC 71
 - 6.3 acres NE 1/4 SE 1/4 as projected within Lacerty DLC 71
 - 0.2 acre NE 1/4 SE 1/4 as projected within Morgan DLC 72
 - 7.15 acres NW 1/4 SE 1/4 as projected within Lacerty DLC 71

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
