CERTIFICATE OF WATER RIGHT

This Is to Certify, That **GERALD T. ODOM**

of **1779 95th Avenue NE, Salem**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Podding River**

a tributary of **Big Podding River** for the purpose of **irrigation of 14.1 acres**

under Permit No. **29558** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **April 13, 1964**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.18 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NE $\frac{1}{4}$** , as projected within English DLC 67, Section 24, T. 7 S., R. 2 W., W. M. Diversion point located 270 feet North and **340 feet West from the NE Corner, Sappingfield DLC 64.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **$2\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres **NE $\frac{1}{4}$ NE $\frac{1}{4}$** as projected within English DLC 67
0.6 acre **NW $\frac{1}{4}$ NE $\frac{1}{4}$** as projected within English DLC 67
0.4 acre **SW $\frac{1}{4}$ NE $\frac{1}{4}$** as projected within English DLC 67
3.2 acres **SW $\frac{1}{4}$ NE $\frac{1}{4}$** as projected within Sappingfield DLC 64
5.6 acres **SE $\frac{1}{4}$ NE $\frac{1}{4}$** as projected within Sappingfield DLC 64
1.1 acres **SE $\frac{1}{4}$ NE $\frac{1}{4}$** as projected within English DLC 67
Section 24
T. 7 S., R. 2 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
