that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.03 cubic feet per second; being 0.78 c.f.s. from Well No. 1, 0.78 c.f.s. from Well No. 2, and 0.47 c.f.s. from Well No. 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL NWL; SEL SWL, NWL SEL, both as projected within Marks DLC 37; Section 17, T. 4 S., R. 1 E., W. M. Wells located: No. 1 - 3280 feet South and 3410 feet East; No. 2 - 1280 feet South and 2010 feet East; No. 3 - 5180 feet South and 2620 feet East; all from NW Corner, Section 17.

The amount of water used for irrigation, together with the amount secured under any other

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to seed 2 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
