CERTIFICATE OF WATER RIGHT

This Is To Certify, That

Box 97, Brooks , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of State of a well a tributary of . for the purpose of Little Pudding River irrigation of 101.3 acres under Permit No. G-3771 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.86 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWL NWL, as projected within Orchard DIC 59, Section 10, T. 6 S., R. 2 W., W. M. Well located 1920 feet West and 610 feet North from SW Corner, Benet DLC 58.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;
