## CERTIFICATE OF WATER RIGHT

## This Is To Certify, That

NEAL W. MILLER

of Route 1, Box 328, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Case Creek and reservoir constructed under Appl. No. R-43897, Permit No. R-4943 for the purpose of a tributary of Willamette River for the purpose of irrigation of 11.0 acres and supplemental irrigation of 146.3 acres under Permit No. 32258 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from . April 18, 1966 for 0.11 c.f.s., August 7, 1967 for 31.3 a.f., that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.11 cubic foot per second from Creek and 31.3 acre feet from reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SEL, as projected within Bower DLC 53, Section 26, T. 4 S., R. 2 W., W. M. Diversion point located 150 feet South and 500 feet West from easterly NE Corner, Bower DLC 53.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4943, and further limited to the use of stored water only on the lands described as supplemental,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
