CERTIFICATE OF WATER RIGHT

This Is to Certify, That HULL LUMBER COMPANY, INC.

of P. O. Box 67, Monroe, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Oliver Creek

a tributary of Mary's River for the purpose of irrigation of 40.65 acres and domestic use of one family

under Permit No. 30103 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 26, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.52 cubic foot per second, being 0.51 c.f.s. for irrigation and 0.01 c.f.s. for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within McCoy DLC 60, Section 10, T. 14 S., R. 6 W., W. M. Diversion point located 1980 feet North and 40 feet East from west NW Corner, Charles DLC 61.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed; and to which such right is appurtenant, is as follows:

1.5 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Haptonstall DLC 55
0.3 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within McCoy DLC 60
1.15 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Haptonstall DLC 55
0.2 acre NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within McCoy DLC 60
12.3 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within McCoy DLC 60
16.4 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within McCoy DLC 60

5.1 acres and
Domestic NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within McCoy DLC 60
0.5 acre NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Charles DLC 61
