CERTIFICATE OF WATER RIGHT

This Is to Certify, That **CARL B. and LILA B. HOLLAND, JR.**

of P. O. Box 495, Coquille, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork Coquille River and a spring

a tributary of Coquille River for the purpose of irrigation of 35.9 acres and domestic use of one family

under Permit No. 29448 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 11, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.46 cubic foot per second; being 0.45 c.f.s. from North Fork Coquille River for irrigation and 0.01 c.f.s. from spring for domestic use

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 11; Lot 6 (SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 14, T. 28 S., R. 12 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.5 acres Lot 1 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 11

0.4 acre Lot 3 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
Domestic and 30.0 acres Lot 4 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)
4.0 acres Lot 6 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
Section 14
T. 28 S., R. 12 W., W. M.

Diversion points located: River - 60 feet North and 930 feet East; Spring - 1390 feet South and 730 feet East; both from NW Corner, Section 14.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
