CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ERNEST H. AERNI**

of Route 1, Box 276, Jefferson, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of one well

a tributary of Saniam River for the purpose of
irrigation of 17.3 acres

under Permit No. G-3249 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 24, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 23, T. 10 S., R. 3 W., W. M. Well located 5070 feet South and 4240 feet West from the NE Corner, Holt DLC 62.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.4 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Holt DLC 62
1.2 acres Lot 7 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 13

3.0 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Holt DLC 62
0.7 acre Lot 4 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 14

3.1 acres Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$)
Section 23

5.9 acres Lot 5 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)
Section 24
T. 10 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
