## CERTIFICATE OF WATER RIGHT

of 17880 SW Blanton St., Aloha ,State of Oregon ,has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Well No. 2

a tributary of Butternut Creek (Tualatin River)

for the purpose of

municipal use under Permit No. G-2064 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 23, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.2 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SE_4^1$ , Section 23, T. 1 S., R. 2 W., W. M. Well located 200 feet North and 780 feet West from SE Corner, Section 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to  $\_$  of one cubic foot per second per acre,

conform to such reasonable rotation system as may be ordered by the proper state officer.
