CERTIFICATE OF WATER RIGHT

This Is to Certify, That HARRY E. and NORLENE E. WARDLE

of Route 1, Box 70, Rogue River, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Evans Creek

a tributary of Rogue River for the purpose of irrigation of 14.05 acres

under Permit No. 18538 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.176 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 11, T. 35 S., R. 4 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

14.05 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
Section 11
T. 35 S., R. 4 W., W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Tract C: All that part of the North Half of the SW $\frac{1}{4}$ of Section 11 in Township 35 South, Range 4 West of the W. M., in Jackson County, Oregon lying between the present county road and Evans Creek.

Certificate of water right issued to Russell B. Johnson and recorded at page 20070, Volume 14, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 18.45 acres. Subsequently, the right to the use of water appurtenant to 4.4 acres was canceled by order of the State Engineer entered June 12, 1969. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Russell B. Johnson.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
