CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ILLAHE HILLS COUNTRY CLUB FRED C. RITNER

of Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River irrigation of 48.2 acres

for the purpose of

under Permit No. 22571 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 27, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.60 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL SWL, NWL SWL, as projected within Ekin DIC 73, Section 31, T. 7 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

21.2 acres SWL SWL
as projected within Ekin DLC 73
Section 31
T. 7 S., R. 3 W., W. M.
26.6 acres NWL NWL
0.4 acres SWL NWL
both as projected within Ekin DLC 45
Section 6
T. 8 S., R. 3 W., W. M.

Certificate of water right issued to Fred C. Ritner and recorded at page 24252, Volume 17, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 186.2 acres. Subsequently, the right to the use of water appurtenant to 138.0 acres was canceled by order of the State Engineer entered October 23, 1968. This certificate is issued to confirm the remaining right to the use of water for irrigation and to confirm a change in point of diversion approved by an order of the State Engineer entered December 22, 1961, and supersedes the certificate heretofore issued to Fred C. Ritner.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
