CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. WHEELHOUSE

of Arlington, State of Oregon, has a right to the use of the waters of Rock Creek

a tributary of John Day River for the purpose of irrigation of 131.0 acres, domestic and stock use and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Grant County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 15, at page 461; that the priority of the right thereby confirmed dates from 1886 - Tract No. 1

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1/40 cubic foot per second per acre irrigated to June 1 and 1/80 cubic foot per second per acre thereafter; further limited to one acre-foot per calendar month to June 1 and four acre-feet per acre during season April 1 to September 30, measured at point of diversion.

The point of diversion is located in the SW 1/4 SE 1/4, Section 32, T. 1 N., R. 21 E., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Certificate of water right issued to A. Wheelhouse and recorded at page 25991, Volume 18, State Record of Water Right Certificates, confirms the right to the use of water for domestic, stock and irrigation of 148.4 acres. Subsequently, the point of diversion for domestic and stock use and for the irrigation of 17.4 acres was changed by order of the State Engineer entered July 28, 1969. This certificate is issued to confirm the remaining right to the use of water for domestic and stock use and irrigation and supersedes the certificate heretofore issued to A. Wheelhouse.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
