CERTIFICATE OF WATER RIGHT

This Is to Certify, That

R. W. RYAN

of Route 2, Box 600, Central Point , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a slough

a tributary of Rogue River supplemental irrigation of 12.6 acres

for the purpose of

under Permit No. 23998 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 9, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 6 (SWL NWL), Section 6, T. 36 S., R. 1 W., W. M. Diversion point located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre Lot 7 (NW NW)
11.5 acres Lot 6 (SW NW)
0.9 acre Lot 5 (NW SW)
Section 6
T. 36 S., R. 1 W., W. M.

Portable pumping from slough between points located 1010 feet East and 1710 feet South; and 610 feet East and 2630 feet South; from the NW Corner, Section 6.

Certificate of water right issued to R. W. Ryan and recorded at page 34351, Volume 26, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 19.5 acres and supplemental irrigation of 12.6 acres. Subsequently, the point of diversion and the right to the use of water appurtenant to 19.5 acres was transferred by order of the State Engineer entered August 6, 1969. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to R. W. Ryan.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
