CERTIFICATE OF WATER RIGHT

This Is to Certify, That H. C. WILCOX

of Route 2, Box 117, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River for the purpose of irrigation of 64.4 acres

under Permit No. 24332 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.68 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 9, T. 6 S., R. 3 W., W. M. Diversion point located 2060 feet North and 7150 feet West from NE Corner, Dorrrough DLC 64.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

14.7 acres Lot 8 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
 0.2 acre Lot 7 (SW $\frac{1}{4}$ NE $\frac{1}{4}$)
 33.0 acres Lot 8 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
 2.1 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$
 0.1 acre SW $\frac{1}{4}$ NW $\frac{1}{4}$
 14.3 acres Lot 7 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)
 Section 16
 T. 6 S., R. 3 W., W. M.

This certificate is issued to confirm a change in place of use and point of diversion approved by orders of the State Engineer entered August 12, 1964, and June 20, 1969, and supersedes certificates of water right heretofore issued to H. C. Wilcox and recorded at pages 30203, Volume 22, and 31728, Volume 23, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
