CERTIFICATE OF WATER RIGHT

This Is to Certify, That D. D. DENNY

of Enterprise, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Wallowa River (Old E. M. & M. Co. Mill Race)

a tributary of _____ for the purpose of
irrigation of 2.0 acres

under Permit No. 11952 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 31, 1935

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.048 cubic foot per second measured at the point of diversion from the stream,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 2, T. 2 S., R. 44 E., W. M. Diversion point located: 70 feet North and 100 feet West from the SE corner of tract 21 in Alderwood addition to Enterprise.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 1 $\frac{1}{2}$ acre feet per acre for each acre irrigated during any thirty-day period from May 1 to July 31, and thereafter shall be limited to a diversion of not to exceed 1 acre foot per acre for each acre irrigated during the remainder of the irrigation season ending October 1,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
Section 2
T. 2 S., R. 44 E., W. M.

This certificate is issued to confirm a change in Point of Diversion approved by an order of the State Engineer entered May 18, 1949, and together with Certificate of water right recorded at page 36494, Volume 28, State Record of Water Right Certificates, supersedes certificate of water right issued to L. E. Jordan and H. A. Gritton and recorded at page 11558, Volume 10, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
