## CERTIFICATE OF WATER RIGHT

**This is to Certify,** That H. C. HOTCHKISS, P. W. HOTCHKISS AND WILLIAM HOTCHKISS, doing business as Hotchkiss Bros.  
 of Valley Falls, State of Oregon has a right to the use of  
 the waters of Chewaucan River, a tributary of Abort Lake  
 for the purpose of the irrigation of 356.2 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
 Lake County, and the said decree entered of record at Salem, in the Order  
 Record of the STATE WATER BOARD of the State of Oregon, in Volume 5, at page 1;  
 that the priority of the right thereby confirmed dates from 1887

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of diversion of 1/25 of a cubic foot per second per acre, and the aggregate quantity set forth below; and said right shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows: (3.9 acre feet per acre during each irrigation season, being the period from January 1 to July 15 of each year) 3 acres in the Southwest quarter of Southeast quarter of Section Twelve: 14 acres in the Northeast quarter of Northeast quarter of Section Thirteen: 5 acres in the Northeast quarter of Northwest quarter; 17 acres in the Northwest quarter of Northwest quarter; 0.5 acres in the Southwest quarter of Northwest quarter; 13 acres in the Southeast quarter of Northwest quarter; 1 acre in the Northeast quarter of Southwest quarter; 10 acres in the Northeast quarter of Southeast quarter; 23 acres in the Northwest quarter of Southeast quarter; 7.6 acres in the Southwest quarter of Southeast quarter and 29 acres in the Southeast quarter of Southeast quarter of Section Eighteen: 27 acres in the Northwest quarter of Northwest quarter, 28 acres in the Southwest quarter of Northwest quarter; 15.5 acres in the Northeast quarter of Southwest quarter; 10.5 acres in the Northwest quarter of Southwest quarter; 9.6 acres in the Southeast quarter of Southwest quarter; 21.5 acres in the Southwest quarter of Southeast quarter and 20.5 acres in the Southeast quarter of Southeast quarter of Section Twenty: 7 acres in the Southwest quarter of Southwest quarter and 3 acres in the Southeast quarter of Southwest quarter of Section Twenty-one: 11 acres in the Northeast quarter of Northwest quarter and 32 acres in the Northwest quarter of Northwest quarter of Section Twenty-eight: 32 acres in the Northeast quarter of Northeast quarter and 5.5 acres in the Northwest quarter of Northeast quarter of Section Twenty-nine, Township Thirty-five South, Range Twenty-one East of Willamette Meridian, in Lake County, Oregon.

Also 24 second feet allowed for the development of 38 horsepower, power developed at Concrete Dam across river. Water returned to river from penstock.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
