CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLARENCE DAVIS

of P. O. Box 384, Rose Lodge, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream and Trout Creek

a tributary of Slick Rock Creek for the purpose of group domestic use of 34 families

under Permit No. 29931 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second; water to be diverted from the unnamed stream when available and any deficiency is to be made up by diversion from Trout Creek, providing that the total quantity diverted from both streams shall not exceed * or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NW 1/4 NW 1/4), Section 1, T. 7 S., R. 10 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

SE 1/4 SE 1/4 Section 35 T. 6 S., R. 10 W., W. M.
Lot 3 (NE 1/4 NW 1/4) Lot 4 (NW 1/4 NW 1/4) SE 1/4 NW 1/4 Section 1 T. 7 S., R. 10 W., W. M.

*the limitation allowed herein.

Diversion points located: Unnamed stream - 100 feet North and 1200 feet West; from SE Corner, Lot 4 (NW 1/4 NW 1/4), Section 1. Trout Creek - 20 feet West from SE Corner, Lot 18, Tract 1, Slick Rock Retreat Subdivision.

Land on which water is to be used is more explicitly described as follows: Lots 1, 2, 3, 4, 7, 10, 13, 14, 15, 16, 17, 18, 19, 20, 22, 24, 28, 30, 31, 32, 37, 40, 41, 43, Tract 1; Lots 2, 3, 6, 7, 8, 10, 13, Tract 2; Lot 1 Tract 3; Lots 2, 4, Tract 5; Slick Rock Retreat Subdivision.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
