## CERTIFICATE OF WATER RIGHT

This Is to Certify, That TRIPLE L RANCHES, INC.

of R. F. D., Fossil , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of John Day River and Lake Creek

a tributary of Alder Creek (Columbia River) for the purpose of irrigation of 20.6 acres and supplemental irrigation of 9.3 acres

under Permit No. 30159 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **December 8, 1964** 

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second, being 0.65 c.f.s. from John Day River and 0.10 c.f.s. from Lake Creek provided that any deficiency in the available supply from Lake Creek may be made up by diversion from John Day River provided that the total for its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SEL, Section 4; SEL NEL, Section 9, T. 9 S., R. 23 E., W. M. Diversion points located: 1210 feet North and 240 feet West; 1440 feet South and 370 feet West; both from SE Corner, Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5 acre feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer.
