CERTIFICATE OF WATER RIGHT

This is to Certify, That ESTATE OF GEO. M. JONES, deceased

of Lakeview, State of Oregon has a right to the use of

~~the waters of~~ Run off waters, by Ravines, tributary of Chewaucan River, Dairy, South and Elder Creeks and Coffee Pot Creek, tributaries of Chewaucan River

for the purpose of the irrigation of 1100 acres of land, domestic and stock use under Proofs No. 96 and 99 and stock use under Proof No. 100

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Lake County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 5, at page 1; that the priority of the right thereby confirmed dates from 1876 as to lands under Proof No. 96; 1887 as to lands under Proof No. 99 and 1890 as to lands under Proof No. 100

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of diversion of $\frac{1}{25}$ of a cubic foot per second per acre, and the aggregate quantity set forth in connection with each tract described below; and said rights shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows: (Proof No. 96 for the irrigation of 20 acres from Run off waters, by Ravines tributary of Chewaucan River, 4.8 acre feet per acre during each irrigation season, being the period from April 1 to September 15 of each year) 10 acres in the Northwest quarter of Southwest quarter and 10 acres in the Southwest quarter of Southwest quarter of Section Thirty-one, Township Thirty-three South, Range Nineteen East of Willamette Meridian, in Lake County, Oregon.

(Proof No. 99 for the irrigation of 840 acres of land from Dairy, South and Elder Creeks, 3.9 acre feet per acre during each irrigation season, being the period from March 1 to August 31 of each year) 38 acres in the Northwest quarter of Northwest quarter; 39 acres in the Southwest quarter of Northwest quarter; 4 acres in the Northeast quarter of Northwest quarter; 35 acres in the Southeast quarter of Northwest quarter; 25 acres in the Northwest quarter of Southwest quarter; 40 acres in the Northeast quarter of Southwest quarter; 32 acres in the Southwest quarter of Southwest quarter; 40 acres in the Southeast quarter of Southwest quarter; 21 acres in the Northwest quarter of Southeast quarter; 38 acres in the Southwest quarter of Southeast quarter; 6 acres in the Southeast quarter of Southeast quarter and 5 acres in the Southwest quarter of Northeast quarter of Section Five: 35 acres in the Northeast quarter of Northeast quarter; 5 acres in the Northwest quarter of Northeast quarter; 11 acres in the Southeast quarter of Northeast quarter; 14 acres in the Southeast quarter of Southeast quarter and 3 acres in the Southwest quarter of Southeast quarter of Section Six: 32 acres in the Northeast quarter of Northeast quarter and 25 acres in the Northwest quarter of Northeast quarter of Section Seven: 40 acres in the Northwest quarter of Northwest quarter; 39 acres in the Northeast quarter of Northwest quarter; 24 acres in the Northwest quarter of Northeast quarter; 25 acres in the Northeast quarter of Northeast quarter; 35 acres in the Southwest quarter of Northeast quarter and 34 acres in Southeast quarter of Northeast quarter of Section Eight: 9 acres in the Southwest quarter of Northwest quarter; 24 acres in the Northwest quarter of Southwest quarter; 7 acres in the Southwest quarter of Southwest quarter and 29 acres in the Southeast quarter of Southwest quarter of Section Nine: 27 acres in the Northwest quarter of Northeast quarter; 17 acres in the Northeast quarter of Northeast quarter; 10 acres in the Southwest quarter of Northeast quarter; 11 acres in the Southeast quarter of Northeast quarter; 8 acres in the Northeast quarter of Northwest quarter; 20 acres in the Southeast quarter of Northwest quarter; 3 acres in the Southwest quarter of Northwest quarter; 23 acres in the Northwest quarter of Southwest quarter; 1 acre in the Northeast quarter of Southwest quarter and 4 acres in the Southwest quarter of Southwest quarter of Section Sixteen, Township Thirty-six South, Range Eighteen East of Willamette Meridian, in Lake County, Oregon.

(Proof No. 100 for the irrigation of 240 acres of land from Coffee Pot Creek, 3.9 acre feet per acre during each irrigation season, being the period from April 1 to September 15 of each year) 30 acres in the Southwest quarter of Northeast quarter; 36 acres in the Southeast quarter of Northeast quarter; 12 acres in the Southeast quarter of Northwest quarter; 16 acres in the Northeast quarter of Southwest quarter; 24 acres in the Northwest quarter of Southwest quarter; 10 acres in the Northeast quarter of Southeast quarter and 20 acres in the Northwest quarter of Southeast quarter of Section Seven: 6 acres in the Northeast quarter of Northwest quarter; 6 acres in the Northwest quarter of Northwest quarter; 28 acres in the Southwest quarter of Northwest quarter and 16 acres in the Southeast quarter of Northwest quarter of Section Eight, Township Thirty-five South, Range Eighteen East of Willamette Meridian, in Lake County, Oregon.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.
