for the purpose of

domestic use and irrigation of 261.5 acres

under Permit No. 9866 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 15, 1930

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.03 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEM SEM, Section 25, T. 5 S., R. 42 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent in case of rotation,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to P. J. Powers, J. R. Wanker and Pondosa Water Company and recorded at page 10747, Volume 10, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 547 acres, domestic and supply for a lumber manufacturing plant. Subsequently, the right to use of water appurtenant to 285.5 acres was canceled by order of the State Engineer entered October 16, 1969. This certificate is issued to confirm the remaining right to the use of water and together with the certificate recorded at page 36582, Volume 28, supersedes the certificate heretofore issued to P. J. Powers, J. R. Wanker and Pondosa Water Company.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
