## CERTIFICATE OF WATER RIGHT

a tributary of Coquille River irrigation of 24.81 acres

for the purpose of

under Permit No. 18027 of the State Engineer, and that said right to the use of said waters has been perjected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 2, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.31 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 10 (SEM SWM), Section 32, T. 29 S., R. 12 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is

appurterant, is as follows:

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point which is 30 lks. South and 30 ft. West of the center of Section 32, T. 29 S., R. 12 W., W.M., Coos County, Oregon; thence West 11.96 chs.; South 11.77 chs.; West 9.72 chs.; South 14.22 chs. to right bank South Fork Coquille River; Easterly along said right bank to the north and south quarter line through said Section 32; North along said quarter line and the west boundary of the county road to the beginning.

This certificate is issued to correct and supersede the certificate of water right issued to E. L. Clausen and recorded at page 17373, Volume 14, State Record of Water Right Certificates so as to correctly describe the lands irrigated.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
