# CERTIFICATE OF WATER RIGHT

This Is to Certify, That

H. A. EMRY, EARNEST JOHNSON and STELLA and VERN McCARTY

of Monument , State of Oregon , has a right to the use of the waters of Spring and Cottonwood Creek

a tributary of for the purpose of irrigation of 45.8 acres, domestic and stock and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Grant County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 15, at page 461; that the priority of the right thereby confirmed dates from 1879

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth cubic foot per second per acre irrigated to June 1 and one-eightieth cubic foot per second per acre thereafter; further limited to one-acre foot per calendar month to June 1 and four acre-feet per acre during season April 1 to Sept. 30, measured at point of diversion.

The point of diversion is located in the Emry - NEW SWM, Section 18, T. 9 S., R. 28 E., W. M. Johnson - SEM NWM, Section 18, T. 9 S., R. 28 E., W. M. McCarty - NWM NEW, Section 12, T. 9 S., R. 28 E., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Certificate of water right issued to H. A. Emry and recorded at page 25147, Volume 17, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 87.5 acres. Subsequently, the right to the use of water appurtenant to 41.7 acres was transferred by orders of the State Engineer entered July 18, 1966 and August 15, 1969. This certificate is issued to confirm the remaining right to the use of water for irrigation and confirms changes in points of diversion approved July 11, 1957 and January 15, 1962, and supersedes the certificate heretofore issued to H. A. Emry.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. WITNESS the signature of the State Engineer, affixed
