and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby confirmed dates from 1902

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.60 cubic feet per second

The point of diversion is located in the SEM NEM, Section 11, T. 35 S., R. 4 W., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

Beginning at a point on the North line of Section 15, T. 35 S., R. 4 W., W. M. which is 708 feet West of the NE Sorner thereof; thence South 419.5 feet; thence North 83° 15' West to the center of Evans Creek; thence in a Northeasterly direction along said Creek to the North line of Section 15; thence East to the point of beginning.

Certificate of water right issued to Paul S. Seeley and recorded at page 36142, Volume 28, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 85.3 acres. Subsequently, the point of diversion for the irrigation of 10.8 acres was changed by order of the State Engineer entered July 28, 1969. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Paul S. Seeley.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
