that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre;

Certificate of water right issued to Isabelle Hutchinson and recorded at page 6387, Volume 6, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 331.4 acres. Subsequently, the point of diversion and the right to the use of water appurtenant to 25.1 acres was transferred and the point of diversion for the irrigation of 117.3 acres was changed by order of the State Engineer entered July 31, 1969. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Isabelle Hutchinson.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
