CERTIFICATE OF WATER RIGHT

This Is to Certify, That PETER C. WESTENSKOW

of Imbler, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Clark's Creek

a tributary of Grande Ronde River for the purpose of irrigation of 97.2 acres of land

under Permit No. 132 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 4, 1909

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.22 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 24, T. 1 N., R. 39 E., W. M. Diversion point located: 2110 feet North and 1780 feet West from the SE Corner, NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

30.0 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$

3.6 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$

This certificate is issued to confirm a change in place of use and point of diversion approved by an order of the State Engineer entered June 6, 1966, and supersedes certificate of water right heretofore issued to John Klinghammer and L. J. Furgason and recorded at page 30038, Volume 22, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
