## CERTIFICATE OF WATER RIGHT

irrigation of 100.0 acres

under Permit No. G-3899 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 1, 1967

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.25 cubic feet per second, being 0.60 c.f.s. from south well and 0.65 c.f.s. from north well

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWA NWA, NWA SWA, both as projected within Cook DIC 86, Section 20, T. 11 S., R. 4 W., W. M. Wells located: 700 feet North and 60 feet East; 2380 feet North and 30 feet East, both from SW Corner, Cook DIC 86. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
