CERTIFICATE OF WATER RIGHT

This Is to Certify, That W. R. WARD

of P. O. Box 333, Bandon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Crooked Creek and two reservoirs constructed under Appl. No. R-41985, Permit No. R-4830

a tributary of Pacific Ocean for the purpose of irrigation, frost control and cranberry harvesting of 8.9 acres

under Permit No. 31786 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 14, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.34 cubic feet per second, being 0.22 c.f.s. for irrigation, 0.56 c.f.s. for frost control and 0.56 c.f.s. for cranberry harvesting

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 7; NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 18, T. 29 S., R. 14 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.7 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
Section 7

3.2 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 18
T. 29 S., R. 14 W., W. M.

Diversion points located: Creek - 490 feet North and 1360 feet East; Reservoir No. 1 - 200 feet North and 1050 feet West; Reservoir No. 2 - 220 feet South and 500 feet West; all from SW $\frac{1}{4}$ Corner, Section 7.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
