## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That R. E. SPROUL

of Mount Vernon , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of McClellan Creek and East Fork Beech Creek

a tributary of Beech Creek irrigation of 16.5 acres

for the purpose of

under Permit No. 28269 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 1, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.41 cubic foot per second, being 0.255 c.f.s. from East Fork Beech Creek and 0.155 c.f.s. from McClellan Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEW NWW, SWW NEW, Section 22, T. 12 S., R. 31 E., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre feet for each acre irrigated during the irrigation season of each year and is subject to the terms and conditions of a stipulation recorded on pages 491 and 492, Miscellaneous Records of the State Engineer and by reference made a part hereof; provided further that the right to use of water is limited to the period when the flow of the John Day River is more than 30 c.f.s. at USGS Gage No. 14-0465 and is more than 20 c.f.s. at USGS Gage No. 14-0480,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Section 22
T. 12 S., R. 31 E., W. M.

Diversion points located: McClellan Creek - 70 feet South and 2160 feet East; East Fork Beech Creek - 2640 feet South and 2690 feet East; both from the NW Corner of Section 22.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
