**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That HARVEY T. GRANGER**

of P. O. Box 296, Jacksonville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Kanes Creek

a tributary of Rogue River for the purpose of irrigation of 56.0 acres

under Permit No. 30504 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 26, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.70 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within T'Vault DLC 37, Section 26, T. 36 S., R. 3 W., W. M. Diversion point located: 60 feet North and 1010 feet West from NE Corner, Swinden DLC 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.6 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$   
as projected within T'Vault DLC 37  
Section 22

1.5 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$   
0.2 acre SW $\frac{1}{4}$  NW $\frac{1}{4}$   
both as projected within T'Vault DLC 37  
Section 26

27.3 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
15.6 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
0.7 acre SW $\frac{1}{4}$  NE $\frac{1}{4}$   
3.1 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$   
all as projected within T'Vault DLC 37  
Section 27

T. 36 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
